The meeting expressed its thanks to the retiring directors for their years of service to the Club. Following the meeting, Kerrie Boyd was appointed interim Company Secretary by the directors while the club seeks to hire a new SFS Secretary Manager.

AMALGAMATION PROPOSAL TERMINATED

The Memorandum of Understanding (MOU) between Sydney Flying Squadron Limited (SFS) and NSW 18 Footers League Limited (A18s) contains restrictions on the SFS that prevent SFS from undertaking, or making decisions on, a wide range of management and operational matters without the consent of A18s. The MOU also contains provisions that permit the MOU and the amalgamation proposal to be terminated by either party if the proposal had not been approved by April of this year.

The new Board of Directors of SFS resolved unanimously that it was in the best interests of SFS that the MOU be terminated to enable the Board to operate in the interests of the SFS without the restrictions previously applying. The amalgamation proposal has been terminated.

For now, an amalgamation is off the table – however this does not mean that we may not revisit this again if that is an appropriate way to secure the future of the club.
